- You are not eligible for this funding if you complete your undergraduate program prior to departure for study abroad program.
- Applicants must be U.S. citizens or permanent residents.
- Study abroad grants may be used for the Summer 2019 only.
- Study abroad grants are one-time only awards; previous recipients of this award are not eligible.
- Funds awarded credit to the student's TCU account. It is the responsibility of the student to notify TCU Financial Services when requesting funds from their account. For more information, you may contact their office at (817) 257-7836.
- Awards are based on the hours indicated on your application. If you choose to enroll in fewer hours, awards will be reduced accordingly.
- All requested information must be complete prior to the disbursement of funds. You may check the status of the information on your portal; my.tcu.edu
- LATE applications will be reviewed on a funds available basis.
